WITH WHAT THE ORIGINAL POSTER WROTE, AND PROVIDE A SECOND CITED EXAMPLE THAT ALSO SUPPORTS THE PERSON'S CLAIM, OBSERVATION, OR STANCE.

Mark, I agree that Mary's lamb should not have been at school. By making the children "laugh and play," the lamb distracted them from their studies and effectively set back their learning by days or even months each time Mary brought him to class (Hale 1830).

TO ANOTHER TEXT OR ANOTHER EVENT. EXPLAIN HOW WHAT THEY WROTE REMINDS YOU OF SOMETHING ELSE YOU READ OR ANOTHER RECENT OR HISTORICAL EVENT. YOU NEED TO BE SURE YOU EXPLAIN WHY THE TWO THINGS ARE ALIKE.

The theme of distraction from appropriate work is apparent in other folk tales, as well. For example, in *The Three Little Pigs*, two of the brothers are so focused on the pursuit of pleasure that they fail to build homes strong enough to protect them from the Wolf. Only the diligence and focus on the third brother--who builds his house from time-consuming brick--saves all three lives (Jacobs 1890).

In the nursery rhyme, Mary is heartbroken simply because the teacher "turned out" her lamb. I can only imagine her emotional anguish had the lamb died in such a violent fashion (Hale 1830).
